The Plan Commission and *Town Board* will review the comments received and consider adoption of the plan update at future meetings, for which separate public notice will be provided.

**A RESOLUTION TO APPROVE AN AMENDMENT AND UPDATE TO

**WHEREAS**, the *Town of* \_\_\_\_\_, Wisconsin, pursuant to Sections 60.10(2)(c), 62.23, 61.35, 60.22(3), and 66.1001(4)(b) of the Wisconsin Statutes, adopted a comprehensive plan on \_\_\_\_\_ as Chapter \_\_\_ of the *Town* code of ordinances; and

**AN ORDINANCE TO ADOPT AN AMENDMENT AND UPDATE TO  
THE TOWN OF \_\_\_\_\_ COMPREHENSIVE PLAN (Sample)**

The Board of Supervisors of the *Town of* \_\_\_\_\_, Wisconsin, do ordain as follows:

**Section 1.** Pursuant to Sections 60.10(2)(c), 62.23, 61.35, and 60.22(3) of the Wisconsin Statutes, the *Town of* \_\_\_\_\_ is authorized to prepare, adopt, and amend a comprehensive plan as defined in Sections 66.1001(1)(a) and 66.1001(2) of the Statutes.

**Section 2.** The *Town Board*, by the enactment of an ordinance, formally adopted the document titled, “*Town of* \_\_\_\_\_ *Comprehensive Plan: 2035*,” on (date) as Chapter \_\_ of the *Town* code of ordinances.

**Section 3.** The *Town Plan Commission*, by a majority vote of the entire *Plan Commission* at a meeting held on (date), adopted a resolution approving the amendment and recommending adoption of Amendment \_\_\_\_\_ by the *Town Board* as the 10-year update to the *Town* comprehensive plan required by Section 66.1001(2)(i) of the Wisconsin Statutes.

**Section 4.** The *Town* published a Class 1 public notice and held a public open house and public hearing on (date) to obtain public comments regarding the comprehensive plan amendment and update.

**Section 5.** The *Town Board* hereby adopts this Ordinance adopting Amendment No. \_\_\_\_\_ as the 10-year update to the *Town of* \_\_\_\_\_ comprehensive plan.
