#### WELCOME AND INTRODUCTIONS

Ms. Anderson brought the meeting to order at 2:10 p.m., introduced herself, and asked those present to introduce themselves. She indicated that roll call would be taken through the circulation of a meeting sign-in sheet.

### CONSIDERATION AND APPROVAL OF MINUTES OF THE OCTOBER 30, 2008, MEETING

Mr. Kacala noted that Ms. Kacmarcik's job title and organization was incorrectly listed on page 1 of the minutes. Mr. Beck stated that her title and other typing errors would be corrected in the final version of

the minutes. Ms. Kacmarcik made a motion to approve the minutes with the corrections, and was seconded by Mr. Kacala. The Workgroup unanimously approved the minutes with the corrections.

[Secretary's Note: The Minutes of the October 30, 2008 meeting have been revised to correct Ms. Kacmarcik's title (Supervisor, Town of Waterford) and Ms. Oliver's name on page 1; the word "in" has been deleted in the second paragraph on page 3, and the last row on the revised Table 2-9 in Attachment 4 has been deleted. The corrected minutes are posted on the website for the Racine County Transit Plan at www.sewrpc.org/racinetransitplan.]

#### CONSIDERATION OF CHAPTER III, "LAND USE AND TRAVEL PATTERNS", OF SEWRPC COMMUNITY ASSISTANCE PLANNING REPORT NO. 286, "RACINE COUNTY PUBLIC TRANSIT PLAN: 2010-2014"

Ms. Anderson turned the meeting over to Mr. Beck, who reviewed with the workgroup the elements of the third chapter of the Racine County Public Transit Plan on a section-by-section basis. During the review, the following questions were raised and addressed

- 1. Referring to Table 3-1, Mr. Kacala asked if the chapter could include a comparison of the Racine County population trends to the trends for the other counties in the southeastern Wisconsin Region. Mr. Beck stated that a table showing such a comparison would be added to the chapter.
- [Secretary's Note: A new table—Table 3-1A, "Historic Population Levels in Racine County and the Southeastern Wisconsin Region"—has been inserted in the chapter before Map 3-1 on page 1b. A copy of the table is in Attachment 1. In addition, the following sentence will be added to the first bullet on page 1 of Chapter III: "As shown in Table 3-1A, the 15 percent growth in population in Racine County between 1970 and 2008 lagged behind that of neighboring Kenosha, Walworth, and Waukesha Counties whose populations grew by 40, 60, and 66 percent, respectively—but was greater than in Milwaukee County, whose population decreased by 11 percent."]
  - 2. Referring to the section describing the characteristics of the transit-dependent population groups, Mr. Kacala noted that the level of educational attainment of the population in a community strongly affects employment and income levels in the community. He stated that the City of Racine has a higher-than-average percent of population without a high school diploma, and that the number of people without a high school diploma is increasing in the City.
  - 3. Referring to the section describing the transit-dependent population groups Mr. Goetsch asked if Commission staff had access to information on the number of adults without drivers' licenses. Mr. Beck stated that Commission staff would provide a summary of that information and include it in the minutes.

[Secretary's Note: Commission staff obtained the following data on the number of valid licensed drivers and the total population, by county:

- 4. Mr. Beck stated that the Employment Transportation Survey conducted by the Racine Area Manufacturers and Commerce had not yet been summarized, and that the section of the chapter identified on page 4 presenting a summary of the results of that survey would be included as an attachment to the meeting minutes.
- [Secretary's Note: The text, table, and map summarizing the findings of the employment transportation survey conducted by the Racine Area Manufacturers and Commerce in fall 2008 are included in Attachment 2.]
  - 5. Mr. Gromacki, referring to Maps 3-4 and 3-13, asked why the portion of the Town of Dover south and east of CTH C was not shown as having a high number of jobs per acre, since it is home to facilities of several governmental agencies, including the Robert E. Ellsworth Correctional Center for incarcerated women, the Southern Wisconsin Center for the Developmentally Disabled, the Wisconsin Veterans Home, and the Veterans Affairs Union Grove Outpatient Clinic. Mr. Beck indicated that Commission staff would check the data and make corrections as necessary.
- [Secretary's Note: The facilities at the aforementioned location are distributed evenly between four public land survey quarter-sections, and the quarter sections have large areas of undeveloped land. According to the Census data displayed in Maps 3-4 and 3-13, a total of 942 jobs are distributed almost evenly between the 647 acres contained in the four quarter sections. The resulting job density is 1.5 jobs per total acre in each quarter section, and is correctly shown on both maps.]
  - 6. Mr. Garner requested that the section on employment in the chapter include a map that was originally developed for the Southeastern Wisconsin Regional Transportation Authority showing the difference in employment densities in 1972 and 2000. Mr. Beck stated that the map would be added to the chapter.
- [Secretary's Note: A new map—Map 3-4A, "Job Density in the Southeast Wisconsin Region: 1972 and 2000"—has been inserted in the chapter after Map 3-4 and the last sentence in the second bullet on page 4 has been reworded as follows: "Map 3-4A shows how employment concentrations in the entire southeastern Wisconsin Region have dispersed greatly between 1972 and 2000. High job densities in Racine County now exist in many locations outside the City of Racine along both Washington Avenue (STH 20) and Durand Avenue (STH 11) in the Villages of Mt. Pleasant and

Sturtevant, respectively, as well as in the City of Burlington CBD." A copy of Map 3-4A is provided in Attachment 3.]

- 7. Several individuals suggested minor changes to the major commercial centers shown in Table 3-8 and Map 3-7 including: adding the commercial area around the intersection of Durand and Lathrop Avenues in the City of Racine; correcting the location of the Shorecrest Plaza Shopping Center to show it is in the City of Racine, not in the Village of North Bay as indicated; and including the STH 36 commercial corridor north of the City of Burlington. Mr. Beck stated that the changes would be made to the chapter.
- [Secretary's Note: Table 3-8 and Map 3-7 were revised to incorporate the changes identified by the workgroup. A copy of revised Table 3-8 is in Attachment 4, and a copy of revised Map 3-7 is in Attachment 5.]
  - 8. Referring to Table 3-9, Mr. DeHahn stated that Sacred Heart Catholic Church School had been renamed "John Paul II Academy" and that St. John Nepomuk Elementary School was no longer in operation. Mr. Beck indicated the table would be corrected to reflect this information.
- [Secretary's Note: Table 3-9 and Map 3-7 were revised to incorporate the corrections. A copy of revised Table 3-9 is in Attachment 6, and a copy of revised Map 3-7 is in Attachment 5.]
  - 9. Referring to Table 3-10, Ms. Kacmarcik asked if the newly-constructed ProHealth Care Clinic at the intersection of STH 36/83 and CTH D in the Village of Rochester should be included, and Mr. Gromacki asked why the Veterans Administration medical facility in the Town of Dover was not included. Mr. Beck stated that staff would add those facilities to Table 3-10 if they met the minimum criteria used by staff to identify medical centers attracting significant trips.
- [Secretary's Note: As noted in footnotes to Table 3-10, a medical facility was included in the table if it was a hospital serving persons of all ages having at least 100 beds and providing inpatient and out-patient facilities and laboratory and clinical services; or, a major medical facility and special clinic offering multispecialty medical services with at least 10 doctors. The ProHealth Care Medical Center in the Village of Rochester has only one full-time physician on staff, and the Wisconsin Veterans Home at Union Grove is an assisted-living community that includes a 120-bed skilled nursing facility offering long-term care. Neither of these meet the above criteria and were not considered to be facilities that would attract a significant number of trips.
  - 10. Ms. Grant asked if any of the major health care providers or provider networks, such as Aurora Health Care, provided transportation to their patients as part of their service. Mr. Beck said that in Racine County, staff had found that none of the health care providers offered transportation for their patients. He noted that in Waukesha County, ProHealth Care does operate its own transportation service for some ProHealth Care patients who do not have other means of transportation.
  - 11. Referring to Table 3-11, Mr. Gromacki suggested that the Robert E. Ellsworth Correctional Center for incarcerated women in the Town of Dover be added to the Institutional Centers category. Mr. DeHahn suggested that the Racine County Law Enforcement Complex on Wisconsin Avenue in the City of Racine be added to the Institutional Centers Category. Mr. Schalk stated that the address listed for the Village of Wind Point Village Hall was the

location of the Clerk's Office, and that the corresponding dot on Map 3-7 was in an incorrect location.

- [Secretary's Note: Table 3-11 and Map 3-7 were revised to incorporate the identified additions. A copy of the revised Table 3-11 is included as Attachment 7, and a copy of revised Map 3-7 is in Attachment 5.]
  - 12. Several comments were made by workgroup members regarding the major employers identified in Table 3-12. It was noted that "JohnsonDiversey" should be listed as one word; that Racine Federated, Inc., was listed with an incorrect address; that the new Kohl's and Menards in the STH 36 corridor north of Burlington should be considered for inclusion on the list; that several employers (ACMI Circon, AMETEK-Lamb Electric Division, and Maple Leaf Farms) should be considered for removal from the list; that the "Town of Caledonia" should be changed to "Village of Caledonia"; and that the Lakeview Neurology Rehabilitation Center should be listed as being located in the Town of Dover instead of the Village of Waterford.
- [Secretary's Note: Table 3-12 and Map 3-8 were revised to incorporate the corrections. A copy of the revised Table 3-12 is included as Attachment 8, and a copy of revised Map 3-8 is included as Attachment 9.]
  - 13. Mr. Kacala observed that some employers in the County use a large number of temporary employees. He stated that since there is no method to estimate the number of temporary employees at each employer, some large employers of temporary workers would not be included in Table 3-12.
  - 14. Referring to Table 3-14, Mr. Schalk stated that Villa Saint Anna was not an operating residential facility, noting that it had been under renovation for several years. He also stated that Waterford Senior Living, a new apartment complex for seniors in the Village of Waterford, should be added to Table 3-14. Ms. Hartog stated that Love, Inc., operates an evening meal service for seniors and should be added to Table 3-14.
- [Secretary's Note: Table 3-14 and Map 3-10 were revised to incorporate the corrections. A copy of the revised Table 3-14 is included as Attachment 10, and a copy of revised Map 3-10 is included as Attachment 11.]
  - 15. Referring to Map 3-11, Mr. Schalk and Ms. Anderson inquired about the information represented with the arrows depicting volumes of 2001 person trips, in particular, the areas between which the trips occurred. Both inquired as to whether the trips volumes identified included trips made to areas outside of Racine County. Mr. Beck and Ms. Dubielzig explained that the arrows in Map 3-11 depicted only the trips in 2001 made between the displayed subareas in Racine County, and that travel between Racine County and the surrounding counties was shown on Map 3-12.

Noting the high volume of person trips in 2001 between eastern Racine County and eastern Kenosha County shown on Map 3-12, several workgroup members asked why there was not more transit service connecting the Cities of Racine and Kenosha. Mr. Beck noted that up to mid-May 2007, the Belle Urban System operated a bus route between downtown Racine and the University of Wisconsin-Parkside where connections could be made with a bus route operated by Kenosha Area Transit. As the Racine bus route was operated principally to serve University students from Racine, the University provided the local funds needed to operate

the route. When the University determined that it needed to use those funds for other purposes and would no longer fund the route after the spring 2007 semester, the route was discontinued by the transit system. Mr. Beck stated that the route would be reexamined during the current study to determine if there are ways of serving the Parkside campus at a lower cost to the University. Mr. Beck stated that the commuter bus route operated by Coach USA-Wisconsin Coach lines, Inc. between Racine and Kenosha would also be looked at for providing express bus service.

- 16. Referring to Table 3-16, Mr. DeHahn indicated that he believed the percent of trips on the Belle Urban System for school purposes would be higher in 2009 than observed in the Commission's 2001 travel survey. He said that the increased cooperation between the Racine Unified School District and the Belle Urban System had led to increased use of the transit system by students. Mr. Garner asked if the high percentage of trips made on the Belle Urban System for school or work purposes was typical for a transit system of its size. Mr. Beck confirmed that many bus systems in Wisconsin and in other parts of the Nation carried high volumes of students, explaining that many similar-sized transit systems operate "tripper" services in the mornings and afternoons that are designed to serve students traveling to and from school.
- 17. Mr. Gromacki noted that the share of Belle Urban System riders in the Commission's 2001 travel survey aged 65 and older—4.3 percent—seemed low. Mr. Beck responded that the number of older riders may be underreported because older riders may be have difficulties filling out the survey or may be reluctant to do so. He stated that Commission staff would check the Belle Urban System's regularly scheduled passenger counts by fare category as a way of validating the percentage of riders that are over age 65.
- [Secretary's Note: The Belle Urban System no longer includes counts of elderly or disabled fares when it conducts its regularly scheduled passenger counts by fare category. Therefore, Commission staff could not verify the percent of riders aged 65 and older on the BUS.]

There being no further discussion on the chapter, a motion to approve Chapter III subject to the changes identified during the meeting was made by Mr. Gromacki, seconded by Mr. Kacala, and approved unanimously by the Workgroup.

#### CONSIDERATION OF CHAPTER IV, "PUBLIC TRANSIT SERVICE OBJECTIVES AND STANDARDS", OF SEWRPC COMMUNITY ASSISTANCE PLANNING REPORT NO. 286, "RACINE COUNTY PUBLIC TRANSIT PLAN: 2010-2014"

Mr. Beck reviewed with the Workgroup the elements of the fourth chapter of the Racine County Public Transit Plan on a section-by-section basis. During the review, the following questions and comments were raised and addressed:

1. Mr. Kacala asked if the standards listed in Table 4-1 were generally-accepted standards typical for transit systems similar in size to the Belle Urban System. He asked if Commission staff had included any standards that were new or different. Mr. Beck confirmed that the standards listed in Chapter IV were typical of those used by transit systems, and that most of the standards in Table 4-1 have been used in the transit development plans that the Commission has prepared in the past for the City of Racine and other bus systems.

- Referring to Table 4-2, Mr. DeHahn asked if drivers participating in volunteer driver programs are required to obtain a Commercial Driver's License (CDL). Mr. Gromacki asked if volunteer drivers needed to obtain special insurance, which could pose a barrier for individuals wishing to be volunteer drivers. Ms. Dubielzig replied that individuals volunteering their services in driver programs did not need to obtain CDL's and should not encounter insurance barriers. She noted that the State of Wisconsin Office of the Commissioner of Insurance recently conducted a survey of the largest writers of personal
- lines of automobile insurance in the State to determine how insurance companies cover drivers who use their personal auto for transportation of persons or property for charitable purposes. Thirty-two companies confirmed that they provide coverage for volunteer drivers under their personal automobile insurance policy, even if the volunteer receives reimbursement of related expenses; two companies responded that they provide coverage, but charge differently if the volunteer receives reimbursement of related expenses.
- [Secretary's Note: A list of companies that provide insurance for volunteer drivers under the personal automobile policy is available on the internet at: http://oci.wi.gov/volunteerins.htm]
  - 3. Ms. Anderson asked if the objectives and standards would include a measure for how well the transit system serves transportation needs that cross County boundaries. She asked if transit service between Racine and neighboring Counties should be included as a separate objective, or if it should be an overriding consideration to be evaluated within the context of the existing objectives. Mr. Beck stated that the service to neighboring counties could be considered within the existing objectives and standards, rather than separately. Mr. Gromacki and Mr. DeHahn agreed that travel between Racine County and neighboring counties should be taken into account. Mr. Gromacki stated that Map 3-12 showed large volumes of trips between Milwaukee County, eastern Kenosha County, and eastern Racine County, while Mr. DeHahn added that the Abbott Laboratories location in Pleasant Prairie was currently undergoing a major expansion and could potentially be a major employer for Racine County residents, who could potentially need some kind of transit service along STH 31 from eastern Racine County to eastern Kenosha County.

Mr. Lowe stated that historically, the need for intergovernmental cooperation has limited the amount of service provided across County boundaries. He pointed out that a regional transit authority (RTA) covering Kenosha, Racine, and Milwaukee Counties could provide and manage transit services that cross County and municipal boundaries with much greater ease than the existing municipal transit operators in Racine, Kenosha, and Milwaukee Counties. Mr. Kacala asked if the discussion to form a permanent RTA for Kenosha, Racine, and Milwaukee Counties would fit into the scope of the Racine County Transit Plan study. Mr. Beck stated that the plan would include a discussion of the need for an RTA.

[Secretary's Note: The Racine County Transit Plan will include a discussion of the benefits of having an RTA in Chapter VI, "Alternative and Recommended Transit System Configurations". This chapter will identify alternative transit system configurations for consideration by the Workgroup, including a discussion of how an RTA would make certain alternatives easier to implement.]

There being no further discussion on the chapter, a motion to approve Chapter IV was made by Mr. Schalk, seconded by Mr. Garner, and approved unanimously by the Workgroup.

#### NEXT MEETING OF THE RACINE COUNTY PUBLIC TRANSIT PLAN WORKGROUP

Mr. Beck previewed the topics of the next Workgroup meeting. He stated that a draft of Chapter V, "Evaluation of Existing Transit Services and Identification of Unmet Needs", of the final report would be presented at the next meeting. The chapter would include an evaluation of the Belle Urban System and the unmet transit service needs in western Racine County. After meeting with the advisory committee on Chapter V, the Commission would look to schedule public informational meetings to give the public an opportunity to view and comment on the work completed to date on the study. Mr. Kacala suggested that in addition to public meetings, Commission staff meet with the board of the Racine County Economic Development Corporation to brief them on the findings of the study and obtain their input on the plan. Mr. Beck stated that the Commission staff would arrange a briefing with the board during that stage in the planning process.

#### **ADJOURNMENT**

There being no further business to come before the Committee, the meeting was adjourned at 4:00 p.m.

#### **Employer Transportation Survey**

In fall 2008, Racine Area Manufacturers and Commerce (RAMAC) conducted a special survey of its members to gather information on the transportation needs of employers in Racine County for use in preparing the Racine County Transit Plan. The survey contained a series of questions, asking each employer to indicate if their location was currently served by a public transit route; if they were having problems recruiting or retaining workers, and if so, whether transportation was a factor; and if their company could be flexible on shift start and end times. The survey also asked for employers' opinions on whether they would consider making a contribution to expand public transportation services in their area and on what types of transit service improvements they wanted to see implemented. RAMAC distributed the survey by sending an e-mail to approximately 1,800 employers on the e-mail lists for RAMAC, the Burlington Chamber of Commerce, the Union Grove Chamber of Commerce, and the Waterford Chamber of Commerce, requesting that they complete an online survey. Follow-up hard copies of the survey questions were sent via regular mail to 87 selected employers that did not complete the online survey. The e-mail requesting employers to fill out the survey, as well as a list of the survey questions, are included in Appendix A.


A total of 155 employers completed the survey. Of that total, 150 were located in Racine County; their locations are shown on Map 3-4B. Table 3-5A summarizes the employers' responses to selected questions, grouped by communities in the County. Based on the surveys that were returned, the following general observations may be made concerning employer transportation needs:

• Only 66 of the 150 employers responding to the survey, or 44 percent, indicated they were served by public transit.

- Only 37 of the 150 employers responding to the survey, or about 25 percent, indicated they had problems recruiting workers, with four of these 37 employers, or about 11 percent, indicating that transportation problems were a significant factor contributing to their recruiting problems. About 20 of the 150 employers responding to the survey, or about 13 percent, indicated they have problems retaining workers, with two of these 20 employers, or 10 percent, indicating that transportation problems were a significant factor contributing to their retention problems.
- About 56 percent, or 84 of the 150 employers responding to the survey, indicated that they could be flexible on the shift start and end times of employees for whom transportation was a problem. However, only four of these 150 employers, or about 3 percent, indicated that they would be willing to make a contribution to expand transportation service in their area through financial support or by cooperating to establish a privately-sponsored bus route or subscription van service.
- In communities currently within the service area of the Belle Urban System, employer survey responses showed mixed demand for expanding existing services. Of the 54 employers responding to the survey from the City of Racine/Village of Elmwood Park, 11 (20 percent) wanted to add evening transit service, eight (15 percent) wanted transit service for other shifts, four (7 percent) wanted an expansion of current routes, and two (4 percent) wanted new routes. Of the 30 employers responding from the Villages of Mt. Pleasant and Sturtevant, six (20 percent) wanted to add evening service, four (13 percent) wanted transit service for other shifts, seven (23 percent) wanted an expansion of current routes, and two (7 percent) wanted new routes.
- In communities outside the service area of the Belle Urban System, most of the interest in new
  public transportation services was reported from employers in the City of Burlington or the
  Rochester/Waterford area. Of the six Burlington employers responding, two (33 percent) wanted

new routes for their area. Of the 19 Rochester/Waterford employers responding, five (26 percent) wanted new routes, and one (5 percent) wanted evening service.




