### **ROLL CALL**

Chairman Colman called the meeting to order at 2:00 p.m. Roll call was taken, and a quorum was declared present.

## DISCUSSION CONCERNING AN APPOINTMENT TO THE EXECUTIVE DIRECTOR POSITION

Chairman Colman indicated that pursuant to Wis. Stats. Sec. 19.85(1)(c), he was requesting a motion for the Committee to adjourn into a closed session for a discussion regarding the potential appointment of an Executive Director for the Commission staff. On a motion by Mr. Dwyer, seconded by Mr. Pitts, and carried unanimously, the Committee adjourned into closed session for that discussion.

At the conclusion of that discussion, the Committee reconvened into open session.

# CONSIDERATION OF ACTION REGARDING NEXT STEPS IN THE INDENTIFICATION OF AN EXECUTIVE DIRECTOR

Mr. Pitts made a motion, seconded by Mr. Schmidt, to appoint Mr. Benjamin R. McKay as Interim Executive Director of the Commission staff pending the final resignation of Mr. Muhs from the staff. The motion carried unanimously.

There was a brief discussion of the need for a sub-committee of the Commission to determine next steps regarding the identification a permanent Executive Director for the Commission staff. At the conclusion of this discussion, Mr. Dwyer moved, seconded by Mr. Pitts, that the Commission Chairman appoint a sub-committee of five or seven members of the Commission to develop a process for identifying a new Executive Director, carry out that process, and advise the Commission or the Executive Committee of a preferred candidate for the position of Executive Director. The motion carried unanimously.

Chairman Colman asked if there were any correspondence or announcements. Mr. Muhs stated there were none.
