

**INCORPORATIONS AND CONSOLIDATIONS IN SOUTHEASTERN WISCONSIN
1984 THROUGH FEBRUARY 2023**

2023

Town of Lisbon (entire Town) incorporated as the Village of Lisbon pursuant to authority under Section 66.0211(5) of the *Wisconsin Statutes*. Certified 2/13/2023.

2020

Town of Vernon (entire Town) incorporated as the Village of Vernon pursuant to authority under Section 66.02162(5) of the *Wisconsin Statutes*. Certified 6/4/20.

Town of Waukesha (entire Town) incorporated as the Village of Waukesha pursuant to authority under Section 66.02162(5). Certified 5/12/20. A lawsuit has been filed challenging the incorporation. The lawsuit is pending.

2019

Town of Raymond (entire Town) incorporated as the Village of Raymond pursuant to authority under Section 66.0203(10) of the *Wisconsin Statutes*. Effective 4/15/19.

2018

Town of Yorkville (entire Town) incorporated as the Village of Yorkville pursuant to authority under Section 66.0203(10) of the *Wisconsin Statutes*. Effective 4/18/18.

2017

The Village of Salem Lakes was formed on 2/14/17 through a merger of the former Village of Silver Lake and former Town of Salem, based on a cooperative plan developed and approved by the former Village and Town.

2015

Village of Somers incorporated from a portion of the Town of Somers. Certified 4/25/15. A cooperative agreement between the Village and Town was subsequently approved which provided for the annexation of much of the remnant Town into the Village effective December 31, 2015. Portions of the Town to be annexed into the City of Kenosha by 2035 under the terms of an earlier agreement between the Town of Somers and City of Kenosha, referred to as "Area B," were excluded from the annexation.

2011

Village of Bloomfield incorporated from a portion of the Town of Bloomfield. Certified 12/20/11.

2010

Town of Summit (entire Town) incorporated as the Village of Summit. Certified 7/29/10.

2009

Village of Bristol incorporated from a portion of the Town of Bristol. Certified 12/1/09. Remaining Town of Bristol annexed into the new Village on 6/29/10.

2008

Town and Village of Rochester consolidated as the Village of Rochester. Certified 12/16/08.

2008

Town of Richfield (entire Town) incorporated as the Village of Richfield. Certified 2/13/08.

2005

Town of Caledonia (entire Town) incorporated as the Village of Caledonia. Certified 10/25/05.

2003

Town of Mount Pleasant (entire Town) incorporated as the Village of Mount Pleasant. Certified 9/16/03.

1989

Town of Pleasant Prairie (entire Town) incorporated as the Village of Pleasant Prairie. Certified 4/5/89.

1984/99

Town of Pewaukee (entire Town) incorporated as the City of Pewaukee. Certified 4/4/84. Incorporation invalidated through court decision. Second incorporation certified 2/15/99.
