The \$3,760,000 in Federal Congestion Mitigation and Air-Quality Improvement Program (CMAQ) funds approved for transit marketing in Southeastern Wisconsin for the years 2011 through 2013, as shown in the above project, is being split to six separate existing projects—region-wide marketing, and local marketing for the Milwaukee County, Ozaukee County, Washington County, City of Waukesha, and City of Racine transit systems, as shown below, based on a breakdown of the split in the CMAQ funds agreed to by the transit operators in Southeastern Wisconsin desiring to use these funds for marketing.
